





ঘ) আনুষ্ঠানিক স্বীকৃতি অর্জনের জন্য আবেদনকারীকে তার জ্ঞান ও দক্ষতার পর্যাপ্ত সাক্ষ্য প্রমাণ অবশ্যই দেখাতে হবে।

ঙ) যে কর্মসূচির জন্য চাওয়া হচ্ছে, প্রদত্ত সাক্ষ্য প্রমাণ তা মূল্যায়নের প্রয়োজনীয় শর্তগুলো মেনে চলার জন্য যদি তা পর্যাপ্ত, যথেষ্ট বিশ্বাসযোগ্য এবং সঠিক হয়, তাহলে পূর্ব অভিজ্ঞতার স্বীকৃতি (আরপিএল) পদ্ধতি তখনই অর্জিত জ্ঞান ও দক্ষতার স্বীকৃতি প্রদান করবে।

চ) যারা তাদের দক্ষতার স্বীকৃতি পেয়েছেন এবং/অথবা প্রত্যয়ন পত্র পেয়েছেন, তারা যদি কোনো একটি যোগ্যতা স্তর সম্পূর্ণ করতে চান বা আনুষ্ঠানিক ব্যবস্থায় তাদের দক্ষতা উচ্চতর স্তরে উন্নীত করতে চান, তাহলে তাদের জন্য আনুষ্ঠানিক প্রশিক্ষণ কর্মসূচিতে প্রবেশ করার সুযোগ থাকবে। পূর্ব অভিজ্ঞতার স্বীকৃতি (আরপিএল) পদ্ধতি বাস্তবায়ন করার জন্য সরকার নিশ্চিত করবে যে :

প্রতিবছর ২.২ মিলিয়ন কর্মক্ষম জনগোষ্ঠী শ্রমবাজারে যুক্ত হচ্ছে। কিন্তু শ্রম বাজারে যুক্ত হওয়া যুবশক্তিকে দক্ষ করে গড়ে তোলা সম্ভব না হলে এ জনমিতিক সুবিধাকে জনমিতিক লভ্যাংশে (demographic dividend) রূপান্তর করা সম্ভব হবে না। অন্যদিকে, বাংলাদেশের শ্রমবাজারের আরো একটি উল্লেখযোগ্য বৈশিষ্ট্য হলো-বৃহৎ অনানুষ্ঠানিক খাতের উপস্থিতি। মোট শ্রমশক্তির শতকরা ৮৫.১% অনানুষ্ঠানিক খাতে নিয়োজিত। এই শ্রমজীবী মানুষদের প্রায় এক তৃতীয়াংশের কোন প্রাতিষ্ঠানিক শিক্ষা নেই। তাই বৃহৎ অনানুষ্ঠানিক খাতের পাশাপাশি বিপুল সংখ্যক স্বল্প শিক্ষিত জনগোষ্ঠীর দক্ষতা উন্নয়ন করে তাদেরকে শ্রমবাজারের উপযোগী করে গড়ে তোলা একটি বড় চ্যালেঞ্জ এবং সে চ্যালেঞ্জ মোকাবেলায় (NSDA) এনএসডিএ কাজ শুরু করেছে। সকল চ্যালেঞ্জ মোকাবেলা করে দক্ষ ও প্রশিক্ষিত মানব সম্পদ তৈরীর মাধ্যমে ২০৩১ সালের মধ্যে উচ্চ মধ্যম আয়ের দেশে এবং ২০৪১ সালের মধ্যে উন্নত আয়ের দেশে পৌঁছানোর স্বপ্ন বাস্তবায়নে জাতীয় দক্ষতা উন্নয়ন কর্তৃপক্ষ সহায়ক ভূমিকা পালন করবে।

Washington Accord (Engineering Programs)

Overview: This multinational agreement set in motion the progression toward the mutual recognition of engineering accreditation. Initiated in the UK by the Engineering Council, the Washington Accord, signed in 1989, is an international agreement among bodies responsible for accrediting engineering degree programs. It recognizes the substantial equivalency of programs accredited by those bodies and recommends that graduates of programs accredited by any of the signatory bodies be recognized by the other bodies as having met the academic requirements for entry to the practice of engineering.

Signatories: Signatories have full rights of participation in the Accord; qualifications accredited or recognized by other signatories are recognized by each signatory as being substantially equivalent to accredited or recognized qualifications within its own jurisdiction.
